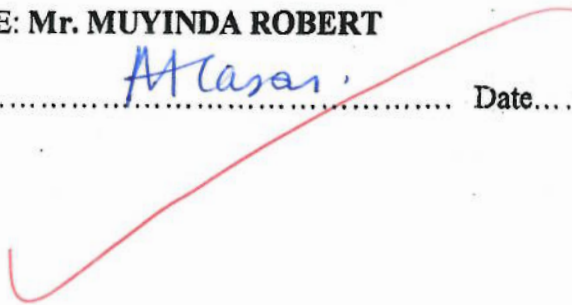

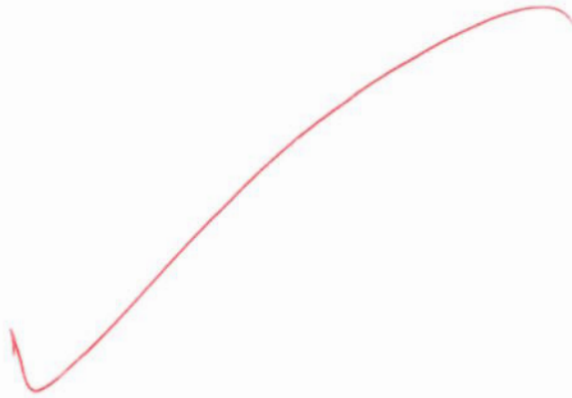

ABSTRACT

This report contains the activities undertaken, skills and qualifications gained, challenges faced during the industrial training, conclusion of the report and recommendations derived from the challenges faced with in bulange Sub County, Namutumba District local government. . The objective of this industrial training is to make students get exposed to field activities, apply the knowledge acquired from the classroom practically. I was attached to the department of animal production. This was followed by orientation whereby I was first introduced to the sub county chief and got engaged in activities such as; castration, dehorning, treatment, debeaking, drug identification, vaccination and others. . These activities made me gain a lot of skills and knowledge like; deworming of animals, skills in Castration, skills in handling different diseases of animals. I also faced some challenges like; walking Long distance, poor roads and lack of transport means, Poor mobilization of the farmers, Lack of veterinary drugs and equipment at the sub county, Poor turn up of farmers for the trainings. In conclusion, all the activities were done and the training was carried out successfully. The technical advice that I shared addressed some of the farmers' problems and fears. Due to some challenges faced, I recommend that Government increases the number of motor cycles to all the sub-counties to solve transport problems during such activities, Some facilitation in form of lunch and transport allowances should be at least allocated to students during their such exercises to motivate them during their training.

1.3 Background of Bulange Sub County

1.3.1 Location and area

Bulange Sub County is part of Namutumba District Local Government and is located in the south of the district with a total land area of 1,373 sq. km. It is bordered by Nabukalu Sub County with in Bugiri District in the south, Butaleja District in the East, Busembatya T.C in Bugweri Distict in the west, Namutumba Sub County in the north and it has eight parishes namely; Bulange, Nawankofu, Mpumiro, Bukenga, kisenye, Buwaga, Bubutya, Kirerema

1.3.2 Political and Administrative structure

The Sub County is under the political leadership of the Lc3 who heads the governing council and the Executives. The Council is the sole decision making body for the Sub county and its decisions are implemented by the Technical Planning Committee staff from various disciplines headed by the Sub County Chief. These include; Production, Works and Technical Services Committee and Finance, Planning, Administration and Community Services Committee
