CHAPTER ONE

1.0 INTRODUCTION

I carried out my industrial training in Kapchorwa district local government under veterinary department. Industrial training is one of the course units run by the university to students pursuing different programmes of study and it is always conducted once at the end of the academic year. This programme took 10 weeks of recess term from 16th may to 22nd July 2016 and it was intended to equip students with field skills and enable them appreciate the correlation between the theory learnt from classroom and the practical skills obtained from the field of study.

1.1 BACKGROUND

Kapchorwa district is one of the districts of Uganda found in the Eastern region in Sebei sub region. Under colonial administration, kapchorwa district was Sebei County located in North Bugisu in the defunct Bukedi district; Kapchorwa district was granted district status in 1st February 1962, shortly before Uganda became an independent country. And of recent it underwent divisions and peeled off two other districts; Kongasis County forming Bukwo district in 2005 and peeled off another giving out Kween district in 2010, it is mainly occupied by the Sabiny tribe and few clusters of Bagishu tribe, and the languages spoken are Kubsabiny, Kiswahili and lugishu among others.. Kapchorwa district currently composed of only one county (Tingey) a total of 10 sub-counties and a municipal council with 3 divisions (Eastern, western and central division).

1.2 Location and size.

Kapchorwa district is located in Eastern Uganda. It borders with the districts of Sironko in the South, Bulambuli in the West and Northwest and kween district in the northeast and East and the Republic of Kenya in the East and south. The district coordinates are: 01 24N, 34 27E with a total area of 1204 km²with an altitude of 1,800m above sea level and current total population of 104580 people with a population density of 309.9 people per km².
