#### 1.0 INTRODUCTION

Title of the organization is Ngetta Zonal Agricultural Research and Development Institute.

#### 1.1 HISTORICAL BACKGROUND

Ngetta ZARDI being a research institute has scanty historical background (historical background about the institute is not clear) but is believed to have started around 1930s as a cotton variety try center under Serere Agricultural and animal research institute (SAARI) currently known as NaSARRI after the first world war of 1939 to 1945.

After the post-World War II the center was used as orientation and resettlement of the war veterans. The center was turned to be a District Farm Institute (DFI) for training farmers on better agricultural practices after independence. In 1999 despite the political insurgency the center was handed over to NARO. The institute is being owned by the government. It works under MAAIF. Ngetta ZARDI offers quality seeds e.g. Maize, Cassava cuttings, Sweet potatoes vines etc. to its customers. They also offer outreach and farmer training to its customers. Persons regarded as customers/beneficiaries of the organization are the staff of Ngetta ZARDI, local community (farmers), institutions (schools)

## 1.2 LOCATION

Ngetta ZARDI is located. 1'17°N of the Equator and 32.56°E of Greenwich meridian. in Northern Uganda, Lira City, Lira City East Division, Telela Ward, Okii oyere Cell along lira-Kitgum high way about 5 kilometers from lira town. The vegetation is savanna grass land with scattered trees and shrubs, the soils are well drained sandy loam and the topography is gentle slope (plateau).
