CHAPTER ONE: INTRODUCTION

1.1.Introduction

Farm and community practice (BSA 2209) is one of the examinable modules that is done in Busitema University, Faculty of Agriculture and Animal Sciences for the period of 10 weeks by students' pursuing Bachelor of Science in agriculture.

1.2. Background of Apapai lower local government.

Apapai Sub-county is found in Kalaki District located in Eastern Uganda to the west of Soroti city and lying approximately between latitudes (width): 1° 47°33.0" (1.7925000°) and longitude (Length): 33°22°30.0" E (33.3416700°). The Sub county headquarters is about 35 km from Soroti along Soroti-Lira highway. It is boarded by Anyara on the North, Tubur Sub County in the north east, Otuboi Sub County on the west, Kakure Sub County on the south and Katine Sub county of Soroti district in the East. The distance from Kalaki to Uganda's capital city Kampala is approximately 184km/114miles

1.2.1. Area and Population

Apapai Sub county has the total land area of 97 sq. Km with the population of 11,324 as per population census 2014 with the overall district population estimated at 109, 874 for the year 2014 with the projection of 138,700 in 2020 as per UBSO (2014); district land area 734.3 km² with the population density of 188.2 km² and annual population change of 4.1% between (2014- 2020). 74.7% of the population are Kumam and 20.5% of whom are Iteso people respectively and predominantly
