ABSTRACT

The following are the units found at Ngetta ZARDI and I managed to visit different farm units with their respective production as listed below.

Goat unit/small ruminant; the most common breed of goat reared at Ngetta ZARDI are local breeds and some exotic breed on the enterprise. Goats are also looked at and reared largely for production milk and meat. The number of goats would have been large but the kids and the adults are largely attack by parasites and also poor management attained to them.

Dairy unit; under this enterprise at the farm, animals are kept at different categories in different sizes as many are milked every morning and evening respectively. The units are less productive due to poor management of the unit leaders and not forgetting climatic and environmental factors.

Adaptive research: under this this unit, different crops are conducted like data collection on beans, fertilizer application on specific soil, climate and phscio-economic environmental characteristics of a given are and the crop were maize, rice, beans and many others. CHAPTER ONE

1.0 INTRODUCTION TO NGETTE ZARDI

Ngetta ZARDI is one of the PARI institutions serving both mid north and northern zone of Uganda i.e. Lango and Acholi sub region respectively

1.1 LOCATION

Ngetta ZARDI is located at the main campus of 1°-17° N of Equator and 32°-56° E, 5 KM (3Miles)on lira Kitgum road that is the main station meanwhile the satellite is located on the skirts of Kitgum town. The main station has about 70.8 hectares.

The climate of the institute is tropical with mean annual temperature ranging from 30° -39° c in February.

1.2 HISTORICAL BACKGROUND

The historical background of Ngetta ZARDI is not clear but what is believe is that it started around 1930s and this was obtained on some of the buildings it was used as the cotton research center under Serere. Again in 1950s, the center was used as the orientation for the war veterans for the World War 2.

At around 1956, the center was given to the ministry of Agriculture and forestry for training farmers for better farming practices and the name was given(LDSI). Lango district social institute. After independence the government upgraded it to district farm institute (DFI) under the ministry of agriculture i.e. Lira and Apac.

In 1999 the ownership and management were given to NARO i.e. National Agriculture research organization and the name was changed from DFI to Ngetta Zonal Agricultural Research and Development Centre. With the decentralization i.e. bringing services nearer to research in 2007 September the name was change from agricultural research and development center to agricultural Research and Development Institute (ZARDI) serving g15 districts in both Lango and Acholi sub region as a public ARDI. Ngetta ZARDI is a semi-autonomous institute under the supervision and guidance of manage committee
