ABSTRACT

This report contains and describes the activities implemented at Goal Uganda, the skills and qualifications gained, challenges faced during the industrial training, conclusion of the report and recommendations derived from the challenges faced The objective of this industrial training is to make students benefit from the skills and knowledge gained from the fields, apply the knowledge they get from the classroom in the field and build confidence in the students. During internship I was attached to the department of Market System Officer. This was followed by orientation where I was first introduced to the staff of Goal and later I implemented the activities such as; attending District coordination meetings, attending weekly planning meeting, had new intern induction with the team of Goal from Kampala, trained on m-water technology, Attended youth led research, participated in data entry, captured and typed minutes for the coordination meetings, attended weekly review meeting, had field visits, quarterly reflection planning meeting. and typed my report and was signed. During internship, I also face some challenges like; poor mobilization of the farmer, lack of veterinary drugs and equipment at the Sub County, limited transport means for field work in the production department and poor turn up of the farmers to the training. CHAPTER ONE

INTRODUCTION

1.1 Organizational Background

GOAL is an international humanitarian agency which is established in 1977 with a global team of 2,400 personnel, dedicated to alleviating the needs of the most vulnerable communities. Currently operating in 13 of the world's most vulnerable countries, GOAL delivers a wide range of humanitarian and development programmes, ranging from humanitarian relief in disaster situations, to focusing on nutrition, food security and building greater resilience and sustainable livelihoods.

1.1.1 General description of the country Programme:

First operational in Uganda in 1979, the current GOAL Uganda country Programme focuses on Health (including WASH, Health Accountability and Nutrition programming); and a marketbased systems approach to improving agricultural livelihoods and WASH. GOAL Uganda mainstreams gender, child protection, social behavior changes and resilience strategies across all programming. GOAL works on a district focused approach and uses a mixture of direct implementation and partnerships with national and international civil society organizations, local government, the private sector and communities to give effect to our mission.

GOAL is currently operational in the North, South, East and West of Uganda with seven established offices in Kampala, Kasese, Hoima, Lira, Bugiri, Moroto, and Agago Districts. GOAL Uganda country Programme is funded by several donors which include MasterCard, charity: water, Irish Aid and some small foundation.

1.1.2 Current program implemented at Lira office

Young Africa Works in Uganda Market for Youth Program is a 5-year Programme founded by MasterCard Foundation. The overall objective is to facilities market systems change that enables 300,000 rural young woman and men between 15-35 years to access dignified and fulfilling work in Uganda (70%women, 10% refugees and 5% PWDs).
