Okoro coffee growers co-operative union limited (OCGCUL) was formed in 1962 and incorporated as a co-operative Union under the co-operative societies ordinance 1947, in its registration number 1948/z. headquarter in Paidha town, Zombo district of west Nile region, OCGCUL serves coffee farmers in the district of ARUA, NEBBI, ZOMBO and PACKWACH through 35 primary co-operative societies which made up the union. The average member in the co-operative societies is 140 people, around 30% of whom are female. Youth members below 35 years average 20% of the entire membership.
