My field of attachment was Kapir Sub County.

Kapir Sub County is one of the sub counties in Ngora district. It's located in the northern part of Ngora District. To the North, it's bordered by Gweri Sub County in Soroti, to the NE is Kapujan Sub County in Katakwi district, to the East is Mukura Sub County in Ngora district and the West Kyere sub county in Serere district.

It has a total land area of 186.4km² out of which 57.84 km² is covered by wetlands.

The sub county comprise of 16 parishes i.e. Kapir ,Koloni ,Omiito ,Agule ,Ajesa ,Akarukei ,Atapar ,Akism ,Ajeelo ,KOKONG ,Oluwa ,Agirigiroi ,Ajuket ,Orsai and Abatai.

Of the 16 parishes, 12 of them lie along the wetland system the main economic activities in the sub county are livestock rearing, agriculture and artisan fishing.
