ABSTRACT

This report contains and describes the activities implemented, skills and qualifications gained, challenges faced during the industrial training, conclusion of the report and recommendations derived from the challenges faced at KYAMPISI sub county, MUKONO District Local Government. The objective of this industrial training is to make students benefit from the skills and knowledge gained from the fields, apply the knowledge got from the classroom in the field and build confidence in the students . During internship I was attached to the department of veterinary. This was followed by orientation where I was first introduced to the DVO ,field supervisor and later I implemented the activities such as; meat inspection, castration of bulls, pigs, goats for fattening, Training of farmers groups on brooder management practices, pregnancy diagnosis ,Artificial insermination, Training of farmers on animal management and security, animal treatment, ear tagging, branding, deworming, wound dressing, vaccination of cattle and dogs in different parishes. These activities have made me to gain a lot of skills and knowledge like; Deworming of small ruminants and cattle, skills in Castration, skills in general management of animals, communication skills and confidence in training farmers on animal management, During internship, I also faced some challenges like; poor mobilization of farmers(vaccination), lack of veterinary drugs and equipment at the Sub County, limited transport. means for field work in the production department and poor turn up of the farmers for trainings. In conclusion all the activities were implemented and industrial training was carried out successfully. I was able to gain a lot from it. I was in position of getting practical skills and knowledge in line with my career and relating with people in the field. The technical advice that I provided addressed farmers' problem and needs. Much as all were successfully done, there were also some little challenges which hindered the smooth running of the activities making me recommend that proper mobilization of farmers must improve for the training programs to solve problems of poor turn up during such activities, government should also increase the number of motorcycles to solve transport problems and more equipment and veterinary drugs to be installed so that animals are

treated and vaccinated in time.

1.3 Background of Kyampist Sub County

1.3.1 Location and area

Kyampisi Sub County Local Government is located in central region of Mukono district Mukono north constituency with a total land area of 1,2147 sq. km. It is bordered by Luweero, Wakiso, Kayunga District,. It has five parishes which are; Kyabakadde, Ddundu, Ntonto, Kabembe, Bulijjo with 56 villages. The Sub county headquarters are located in Kyampisi village, along Namasumbi road and it is about 3km from Kalagi Gayaza road.

1.3.2 Political and administrative infrastructure

The Sub County is under the political leadership of the Le3 who heads the governing council and the Executives. The Council is the sole decision making body for the Sub county and its decisions are implemented by the Technical Planning Committee staff from various disciplines headed by the Sub County Chief. There are 2 Sectorial committees of the Sub county council each headed by a secretary (executive) namely; Production, Works and Technical Services Committee and Finance, Planning, Administration and Community Services Committee.
