CHAPTER ONE:

1.0. INTRODUCTION

This Industrial Training attachment was done from May 21st - July 27th 2018 at Kumi Municipal Council. I was endorsed to conduct an industrial training [IT] from any recognized agricultural institution as it was one of the requirements needed to get the award of Diploma in Animal Production and Management [DAP] of BUSITEMA UNIVERSITY ARAPAI CAMPUS.

1.1.0. LOCATION AND BACKGROUND OF KUMI MUNICIPALITY

1.1.1. Historical Background and Administrative set up

Kumi Municipality started as a colonial administrative Centre with authority to maintain law and order and collect taxes for the provision of social services e.g. Health, Education and Roads. The Municipality later established itself as a commercial Centre with the arrival of Asians and building of the railway in about 1928. Kumi Town was declared a Planning Area in 1974 under the status of a Town Board.

Later on it was declared a Town Council in 1975 upon Kumi District being Created out of Mother Teso District in 1975 hence its name. Kumi Municipal Council was upgraded on 1st July 2015 having been elevated from the Town Council of Kumi, by adding 5 parishes of Kumi Sub County in the North and 4 parishes from Atutur Sub County in the South. It started operating as Municipal Council a Year later in July 2016.

The municipal is made up of two divisions, 14 wards and 26 cells.

The present day boundaries of the Municipal include Atutur and Ongino Sub County to the East, Kumi Sub County to the North, Nyero Sub County to the West and Kanyum Sub County to the South.

1.1.2. LOCATION OF KUMI MUNICIPAL COUNCIL

Kumi Municipality is located in Kumi district in Eastern Uganda, and it is approximately 305 Kilometers from Kampala city on the Kampala -Mbale- Soroti highway. It lies approximately between latitude 1°10' North and 1°35'North and Longitude 33°30'East and 34°20'East Covering an approximate land area of 35 Square Kilometers. It is the main Commercial Centre and houses the Political and Administrative Headquarters of the Kumi District.
