

ABSTRACT

The field attachment was carried out at Gulu District Farmers Association (GDFA) which is a member-based organization that was formed in 1992 with the objective of mobilizing the farmer community to have one voice under one independent umbrella organization. Gulu DFA is also registered member of the Uganda National Farmers Federation (UNFFE), the umbrella body for all farmer organization in Uganda. Gulu DFA is located in Northern Parts of Uganda and currently have registered membership of 25000 farmers and 834 Registered Farmer groups in the whole of Gulu and Omoro district respectively.

Gulu District Farmers Association (GDFA) is dedicated to eradicating poverty in the smallholder's farmers households where the majority of the regions poorest, laborers, herders, fishers and small-scale entrepreneurs depend on agriculture and related activities to survive. We give special attention to gender differences and to empower women, who account for a disproportionate numb.

Internship training is one of the practical requirements with the aim of equipping students with practical skills and getting exposed to the work environments carried out for a period of ten weeks from 20.05.2019 to 26.07.2019 on a theory ground like farmers training and practicals like demo site setting at Gulu DFA located at Lalogi sub-county in Omoro district.
